3.4 Custom Package:

- Pricing and features vary based on client needs
- Custom-built systems (e-commerce, CRM, advanced booking, etc.)
- Fully designed around your branding, features, and workflow
- Timeline and domain cost will be included in your custom quote
- We handle the setup domain & hosting

4. Domains

- For Starter, Growth, and Custom Packages, domains are **quoted separately** based on extension (.co.za, .com, .net, etc.).
- Domains are billed **monthly** and not yearly.
- Clients will be given options and pricing before final confirmation.
- Dream-Web will handle domain registration, linking, and configuration.
- Ownership of the domain and website remains with the client once paid for in full.
- Dream-Web manages the domain, hosting, security, and monthly updates as part of the active service agreement.

5. Payments

- All packages are billed monthly and must be paid in advance.
- Payments can be made via EFT, PayFast, or other methods listed on our invoice.
- Services will only commence once the first month is paid.
- Late payments over 7 days will result in paused service or hidden websites until payment is made.
- If no payment is received after 30 days, we reserve the right to terminate the agreement and remove hosting or access to the website.

6. Client Responsibilities

To ensure smooth and fast delivery of services, the client agrees to:

- Provide clear and complete content, images, and business info on time.
- Review work and respond to approval requests within 3–5 business days.
- Ensure all materials provided are legal and owned by them (no copyrighted images, etc.).
- Maintain secure login credentials for email, domain, and website platforms.

7. Project Timeline

- Starter & Growth: 8–16 working days from payment and content submission.
- Enterprise: 16–27 working days.
- Custom: Based on project scope (given in quote).
- Delays caused by the client (no content, no response, etc.) may extend deadlines.

8. Revisions

- Packages include a set number of content edits per month.
- Unused updates do not carry over to the next month.
- Major changes (redesigns, new layouts) are quoted separately.

9. Refund Policy

- No refunds once design work or development has started.
- Domain and hosting payments are non-refundable once registered.
- If the client chooses to cancel mid-project, only unused time will be credited at our discretion.

10. Termination & Suspension

- You may cancel anytime with 7 days' notice before the next billing cycle.
- If cancelled, we will give you all website files and access once final payments are received.
- We reserve the right to suspend service for non-payment, abuse, or breach of these terms.

- All original content and code developed for your site becomes yours once paid for in full.
- We may use snippets (non-confidential) for future templates or internal projects.
- You may not resell or reuse our work without permission unless agreed in your quote.
- Website and domain ownership belongs to you (the client), but Dream-Web manages
 the ongoing website operations, security, maintenance, and content updates under
 your monthly service plan.

12. Support & Maintenance

- Starter/Growth: Basic support during business hours.
- Enterprise: Priority & 24/7 support.
- Custom: Support as outlined in your quote.
- Emergency fixes (server crash, broken pages) are handled as top priority.
- Ongoing hosting and backups are not included unless stated.
